

NALSA (Effective Implementation of Poverty Alleviation Schemes), 2015

1) Background

The Legal Services Authorities Act, 1987 hnuiaia Section 4 (l) angin, he Act hnuiaiah hian National Legal Services Authority hi Central Authority tih a ni a, mipui leh hnena legal literacy leh legal awareness theh darh, a bik takin, hnu fualte tana social welfare legislations-a dikna chanvo, hamthatna leh vohbikna leh dan siam, chumi rualin enkawlina dan tur ruahman tura beisei a ni a. The Legal Services Authority Act, 1987 in a dah pawimawh em em chu - Legal Services Authority te hi mi hnuaihngung te lakah mawh an phur bakah mi tupawhin sum leh pai dinhmun vang emaw leh thildang, rualban lohna vang emawin an dikna rahbehsak an ni em tih finfiah te hi an mawhphurna a ni.

Chhan hrang hrang heng - khawtlang in relbawl thatloh vangte, sum lam tlakchham vang leh inthliarhranna leh thildang vangtein mi rethei zawkte`n chhawmdawlina hi an hmuh thei lo thin a. Rethei zawkte`n hamthatna an hmuh theihna turin legal services authority ten tihtur tam tak an nei. Legal services authority-te hi an hnathawhte thlirin retheihna tihnepna kawngah hian an inhme hle. Chuvangin, he scheme hi retheihna tihnep kawngah leh hamthatna hmu thei tur atana tangkai tak a ni. He scheme duan anih dawn hian, dinhmun azirin mamawh dan inanglo a awm thei dawn a ni tih hriain; national scheme hi mamawh dan azira hman tura duan a ni. Retheihna hi chi hrang hrang awmin sum lakluh lam ringawt ni lo, hriselna lam (rilru lam huamin), in leh lo, eitur tha, eizawna, pension, nu enkawlina, nausen thi, tui hmuhna, zirna in, inthiarna, subsidy, inenhranna leh thil dangte a huam a. State leh district chhunga scheme hman a nih dawnin, legal services authority-te chu retheihna chhiar sen loh lo hmachhawn tawh te hriatpui tura beisei an ni.

4) Scheme thil tumte :

Scheme thil tum tlangpuite chu a hnuaiia mi ang hian :

- 2) Mi rethei zawk ten Poverty Alleviation Scheme an hmuh theih nan national, state, district leh taluka level-ah legal aid leh support services tih changtlun.
- 3) District Authority member, Taluka Legal Services Committee member, panel lawyer, social worker, para-legal volunteer leh legal aid clinic-a zirlai naupangte

kaltlangin Poverty Alleviation Scheme chungchang awareness hmanga thehdarh.

- 4) Poverty Alleviation scheme chungchanga central emaw state scheme, policy, regulation, policy directive, convention, rules leh report awm te leh hemi scheme tana fund hmuh hnuhnun ber chungchang telin database siam.
- 5) Panel lawyer, para-legal volunteer, Poverty Alleviation Scheme tana officer leh legal aid clinic a zirlai naupang thu thin ten he scheme atana hma an lak lehzual theihna atan training leh orientation program buatsaih leh
- 6) Sawrkar zawng zawng, thuneitu, NGO leh organization dang mirethei zawkte tana thawk thin te ten thawhhona tha neih.

5) Identification of Poverty Alleviation Schemes

- 1) State Authority tinte`n Poverty Alleviation Scheme awmsa state chhunga hman theih tur an zawng chhuak ang a, State chhunga District Legal Services Authority zawng zawngah thla sawm pahnih dan zelah list chu an thawn kual ang. Chung list huam chin tur chu a hnuai mi ang hian:
 - a. Poverty Alleviation Scheme State chhunga hman theih leh kha mi kuma hman theihna district hming.
 - b. Poverty Alleviation Scheme tinte a hamthatna hmu tur ruahman.
 - c. Poverty Alleviation Scheme tinte ngaihvenna atan thunei emaw officer ruatte hming.
 - d. Poverty Alleviation Scheme tinte dilna atana lehkha pawimawh thil tel ngaite tarlan;
 - e. Poverty Alleviation Scheme tin hnuai hamthatna awmte;
 - f. Central sawrkar emaw State sawrkar emaw an pahnih atanga Poverty Alleviation Scheme tinte tana fund dah, a kum te tein.
- 2) State Authority tin ten sub-clause (1) hnuai list an siamte chu District zawng zawngah kumtin thawn kual tur ani. Central Authority hnenah a copy thawn tel tur ani.
- 3) State Authority ten sub-clause (1) a mi angin list chu an web-site ah upload tur ani.
- 4) Sub-clause (1) hnuai list siamte ni 7 chhunga hmuh anih hnuah District tin ten ahnuai mite hnenah list hi thawn thin tur ani :

- a. District chhunga Taluka Legal Services Committee zawng zawng;
- b. Distrct chhunga Village Panchayat zawng zawng;
- c. Legal services clinic-a thawkte, Panchayat-a memberte, law zirlaite, leh para-legal volunteers he scheme kalna atana pui thintu te.

6) Organisation of Awareness programme

- 1) State Authority ten District Authority-te nena tang kawpin District chhung atana Poverty Alleviation Scheme hrang hrang chungchang awareness programme buatsaih turin hma an la ang. Taluka Legal Services Committee-te pawhin awareness buatsaih tura hma la in Panchayat meetingah te, town hall meetingah te, Pulse Polio camp-ah te, kutnaa puipunna hmunah emaw khawtlang puipunnaah te Poverty Alleviation Scheme hmuhna atan legal services-te awm thu te an sawi ang.
- 2) State Authority zawng zawng ten an huam chhunga programme an neihte list chu Central Authority hnenah thla ruk dan zelah an thawn thin ang.

7) Legal Services Officers and Para-legal Volunteers

- 1) District Authority tinte leh Taluka Legal Services Authority ten he Scheme atan hian panel lawyer pathum tal Legal Services Officers atan a ruat ang.
- 2) District Authority ten he scheme thawk tur hian Legal Services Officer-te hnuaiiah PLV team a din anga, sawrkar hnuaiia scheme hrang hrangte hmu thei turin Legal Services Officer ten an team zinga PLV te chu tanpuina pe turin a hrih ang.
- 3) District Authority ten panel lawyer te, legal services clinic-a thawkte, panchayat-a memberte, law zirlaite leh para-legal volunteers-te hnenah abik taka training programme buatsaihin scheme tana hmalakna kawnga pui turte, mi rethei zawk ten Poverty Alleviation Scheme kaltlanga hamthatna an hmuh theih chungchang an hrih hria ang.

8) Legal assistance for access to Poverty Alleviation Schemes

Poverty Alleviation Scheme hnuiaia scheme hmthatna diltu zawng zawngte chu dan lam puihna pek vek tur an ni. Dan lama puihna hi hemi scheme hnuiaia Legal Services Officer-te emaw volunteers ten pein a hnuiaia mi ang hian.

- 1) Scheme beneficiary-ten Poverty Alleviation Scheme tinte chhunga hamthatna an hmuh theihthe chu hrilh nise.
- 2) Poverty Alleviation Scheme hnuiaia eng hamthatna pawh nise hmu thei turin lehkha pawimawh zawn kawngah Scheme Beneficiary-te puih.
- 3) Poverty Alleviation Scheme hnuiaia in ziak lut turin Scheme Beneficiary-te chu thuneitu emaw officer emaw hming leh address kimchang hriattir tur ani.
- 4) Poverty Alleviation Scheme hnuiaia thuneitu emaw officer emaw va pan turin legal services clinic-a para-legal volunteer –te chu Scheme Beneficiary-te kalpui tura ruahman tur a ni.
- 5) Poverty Alleviation Scheme hnuiaia Scheme Beneficiary te hamthatna hmuh theih amaherawhchu thuneitu atana ruat emaw officer tu ber emaw in an pe duhlo anih chuan Scheme Beneficiary ten Legal Services Officer emaw para-legal volunteers te hnenah lungawi lohna an ziah luh duh leh duh loh chungchanga an ngaihdan zawh tur a ni.
- 6) Sub-clause (5) hnuiaia lungawih lohna dawn zawng zawngte record siam vek tur a ni.
- 7) Scheme Beneficiary-te hnenah Legal Services Officer-te biak pawh theihna (phone number) pein biakpawh theih an nih thu hrilh bawh tur a ni.

9) Action by Legal Services Officers on complaints

- 1) Clause 8 sub-clause (5) hnuiaia lungawi lohna dawn anih in, Legal Services Officer ten lungawi lohna thlentu chu thuneitu emaw officer-te hnenah kalpuiin Poverty Alleviation Scheme hnuiaia hamthatna an hmuh theihthe hmu ngei thei turin an pui ang.
- 2) Thuneitute emaw officer atana ruatten Beneficiary lungawilohna thlentu chu Poverty Alleviation Scheme-ah a la ziak lut lo anih chuan, Legal Services Officer ten District Authority hnen an thlen ang. Lungawilohna lehkha thehluhah chuan Poverty Alleviation Scheme hnuiaia an thu thlen lo ziak lut duhlotu thuneitu emaw officer emaw awm dan, thil chungchang nih dan leh lehkha pawimawh thehluh kimloh vanga hnial a ni em tihte ziah lan tur a ni.

10) Actions by District Authority and State Authority on complaints

- 1) Thuneitu emaw officer atana ruatte chungchanga lungawilohna dawn a nihin, District Authority ten officer-te chu va biain, Poverty Alleviation Scheme hnuaiia hamthatna awmte an dawn tir loh chhan an zawt ang. Chhan leh vang chhanna mumal an nei lo anih chuan District Authority ten an department-a officer lian zawkte biain a chhan leh vang an zawt ang.
- 2) Officer lian zawk ten hamthatna an dawn tir loh chhanah District Authority-te duhthu a sam lo anih chuan State Authority-te an bia ang.
- 3) District Authority atanga hemi chungchang dawn anih chuan, State Authority ten department changtute atanga hamthatna an hmuh ngei theihna turin hma lain, legal proceeding pawh an ti thei ang.
- 4) District Authority ten para-legal volunteers emaw legal services clinics-te kaltlangin hamthatna hmu theite lungawilohna thlen dinhmun an hriattir thin ang.

11) Evaluation of the Scheme

- 1) Legal Services Officer tin ten Scheme tina Beneficiary dan lama puihna diltute chu bawhzuiin hetiang hian an record ang :
 - a. Poverty Alleviation Scheme hnuaiia inziaklutte`n hamthatna an hmu em.
 - b. Poverty Alleviation Scheme hrang hranga in ziak lut tur leh hamthatna dawng turin Scheme Beneficiary ten harsatna an tawk em.
- 2) District chhunga Legal Services Officers ten sub-clause (1) anga an thil hmuh zawng zawngte chu District Authority-in lakhawmin State Authority hnenah thla ruk danah zel an thawn ang.
- 3) State Authority-in sub-clause (2) angin District Authority zawng zawng atanga lehkha dawnte chu a hlawma dahin, he scheme kal dan leh tangkai dan thlirletna nei turin thla ruk danah zel meeting neih tur a ni. Meeting minute chu record-in mipui hmuh theih tura pho lan tur a ni.
- 4) Sub-clause (3) anga meeting neihnaah State Authority ten Poverty Alleviation Scheme chungchangah Scheme Beneficiary te tan hamthatna dawn chungchanga harsatna awm nia an hriat chuan, Central Sawrkar emaw State Sawrkar emaw hnenah Poverty Alleviation Scheme hmasawn leh tangkai theih nan a hriattir ang.
