

NALSA (Legal Services to the Mentally Ill and Mentally Disabled Persons) Scheme, 2015

BACKGROUND

India hi UN Convention ‘Rights of Persons with Disability (CRPD) 2008’ tihah pawh hming sign-tu zingah a tel nghe nghe a, kan ramin a convention a pawm ve takah chuan, kan dan hman laiah pawh an dikna chanvo zalen takin an hmang em tih leh midangte pha chiah lo (rilru kimlo leh rilru lama harsatna telin) ten midang ang thova en an ni em tih enfiah leh dan hmaah midang ang thova hriat leh dan lama venhimna an hmu em tih enfiah tur a ni. Convention hian rualbanlote pawhin midang ang thoin dan an hmang em tih enfiah turin min duh a ni.

Legal Services Authorities Act, 1987-a Section 12 hnuai Section 2 clause (i) Persons With Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995-a rualbanlo tih a sawifiah leh Section 2 clause (q) Mental Health Act, 1987-a psychiatric hospital emaw psychiatric nursing home-a awm a sawite hian a thlawnin dan lama tanpuina an dawng thei a ni. Hei vang hian rilru lam harsatna neiten tangkai zawka dan lama puihna an hmuh theih nan kum 2010 khan NALSA-in scheme a duang a, Legal Services Authorities Act, 1987-a Section 4 (b) hnuai a dah nghe nghe a ni.

Heng mite hnena thawhchhuah hi a tul a ni. A lan danah chuan SLSA ten a pan tute chauh an ngaihtuah niin a lang a. Court kaihnawih thildang tam tak thawh tur a la awm bawk.

OBJECTIVES

A thiltum chu, rilru lama harsatna nei emaw rilru lama rualbanlote enhran an ni em tih leh midang ang thoin danin a tiam angin an dikna chanvo hmu thei tura tanpui an ni em tih enfiah te a ni.

PLV, Legal Services Clinics, Front Office, Panel Lawyers leh Retainer Lawyers tihte hi National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010 leh National Legal Services Authority (Legal Services Clinics) Regulation, 2011 leh the NALSA Schemes for Para Legal Volunteers (Revised) leh Module for the Orientation – Induction- Refresher Courses for PLV Training nen a inang a ni.

PART-I:

PRINCIPLES

Rilru lama harsatna nei emaw rilru lama rualbanlo te dawr lain Legal Services Institutions ten a hnuai amite hriatreng tur ani :-

Rilru lama rualbanlote tana dan siamte chu (i) Persons with Disability Act, 1995 leh; (ii) National Trust for the Welfare of Persons with Autism, Cerebral Palsy Mental Retardation and Multiple Disabilities Act, 1999.

- (3) Rilru lama harsatna nei leh rilru lama rualbanlo ten mimal dikna chanvo leh mimal zalenna an hmang thei** – Rilru lama harsatna nei leh rilru lama rualbanlote tan a thlawna dan lam tanpuina pek chungchangah hian anmahni chawikan, venhim leh mimal dikna chanvo leh mimal zalenna an hmang em tih enfiah hi legal services institutions-te mawhphurhna a ni.
- (4) Rilru lama harsatna neite leh rilru lama rualbanlotea zahawmna inphumte zah sak-** Legal services Institutions ten rilru lama harsatna neite leh rilru lama rualbanlotea zahawmna inphumte zah a, anmahni inrelbawlina kawngahte an chawisang ang.
- (5) Thliar hran loh -** Legal services institutions-ten rilru lama harsatna neite leh rilru lama rualbanlote chu an dinhmun avangin an thliar hrang tur a ni lo. Duat tak leh zaidam taka buaipui zawk tur an ni.
- (6) Ngaihnathiamna :** Rilru lama harsatna neite emaw rilru lama rualbanlo ten scheme, programme, facility emaw tanpuina pek thinte inang tlanga an hmuh theihna turin legal services institutions-ten hma an la ang.
- (7) Rilru lama harsatna nei inenkawlina tura dikna chanvo** – Indian Constitution-a Article 21 atanga lak chhuah inenkawlina leh hrilselna lam enkawlina atana dikna chanvo tih hi rilru lama harsatna neite tan pawha hman theih a ni. Chin chang hriat loh vangte emaw, puithuna atthlak vangte emaw, hmanrua emaw, inthliar hranna emaw vangtein rilru lama harsatna neiten enkawlina an dawnglo thin a. Chuvangin, Mental Health Act, 1987-a Chapter-IV angin heng rilru lama harsatna nei ten psychiatric hospital emaw psychiatric nursing home-ah te enkawlina an dawng em tih legal services institution ten an enfiah ang.

- (8) Inenkawlina atan remtihna** – Rilru lama harsatna neite enkawl an nih dawnin an remtihna lak hmasak a ni em tih legal services institution ten an enfiah ang. Remtihna pe thei dinhmunah a ding lo anih chuan a chungte emaw thiante remtihpuina lak nise, an awm lo anih chuan Mental Health Act, 1987 Part II Chapter V hnuai mi angin court duh dan enfiah tur a ni.
- (9) Rilru lama buaina neite tihduhdah leh chhawr laka venna** – Rilru lama buaina neite, a bik takin hmeichhiate hian tihduhdahna an tuar nasa bik a. Chuvangin legal services institution ten heng rilru lama buaina neite tihduhdahna, mipat hmeichhiatna lam chhawr an tawk fo thin. Legal services institution ten tanpuina pein tiduhdahtu leh chhawrtute chungah hma an la ang.
- (10)** Rilru lama buaina neite leh rilru lama harsatna neite an dinhmun avangin chinchang engmah an hriattheih loh avangin hriatna pawh an hmang thei lo thin. Dan lam bel tur pawhin an hrilh hriat theih loh thin a ni. Chuvangin, legal services institution ten mimalin emaw a huhoin emaw dan lama an theih chin leh mamawhte an ngaihtuah sak ang.

PART-II

LEGAL SERVICES TO THE MENTALLY ILL AND MENTALLY DISABLED PERSONS IN PSYCHIATRIC HOMES, HOSPITALS AND OTHER SIMILAR FACILITIES AND JAILS.

Judicial Magistrate te pawhin hetiang thil an tih hmain mithiam emaw psychiatrist te rawn hmasak tur a ni. Supreme Court thupek angin Judicial Magistrate-te pawhin an case neih zat leh

hmun him zawka thawnte leh hmalakna te High Court-ah quarterly report an pe thin ang.

Supreme Court of India-in thubuai an ziahluh zawng zawng Public Interest litigation anga dawnte chu High Court-ah ziak lut vek turin High Court tinah ngen niin, Supreme Court of India thupek anga kalna kawngah High Court Legal Services Committee ten High Court an pui ang.
